Greetings, Fellow Legionnaires;

Welcome! To our two newest members: Leo Gonzalez, USMC, Global War on Terrorism; and Todd Verboort, USA, Lebanon/Grenada. Glad to have you aboard.

It's that time of year again. My, Time does fly when you're not paying attention. We will be taking our first round of officer nominations at our March general membership meeting. All officer positions will be available: Commander, Vice Commander, Adjutant, Chaplain, Sergeant-at-Arms, Finance Officer, Post Historian, and Member-at-Large Position 1. As with all organizations which have a three-member director or member-at-large position, these positions rotate every three years. Member-at-Large Position 1's three-year position has rotated around and Positions 2 and 3 now have 1 and 2 years left, respectively. If any of these officer positions are something you may be interested in, don't hesitate to step up.

You will note that on the Calendar of Events there is a mention of "The Four Chaplains Remembrance Day" on February 3<sup>rd</sup>. While our Post does not have a dedicated observance of the day, some Posts do – Albany Post 10 will have their observance on February 1<sup>st</sup>. (See <https://www.albanypost10.org/commander-s-announcements/4-chaplains-2026.>) The **Four Chaplains** were four chaplains who died rescuing civilian and military personnel as the American troop ship SS *Dorchester* sank on February 3, 1943, in what has been referred to as one of the worst sea disasters of World War II. The relatively new chaplains all held the rank of first lieutenant. They included Methodist minister the Reverend George L. Fox, Reform Rabbi Alexander D. Goode, PhD, Catholic priest Father John P. Washington, and Reformed Church in America minister the Reverend Clark V. Poling.

The *Dorchester*, a civilian liner, had been converted for military service in World War II as a troop transport of the War Shipping Administration. The ship left New York on January 23, 1943, en route to Greenland, carrying approximately 900 as part of a convoy of three ships escorted by Coast Guard Cutters *Tampa*, *Escanaba*, and *Comanche*. During the early morning hours of February 3, the vessel was torpedoed by the German submarine *U-223* off Newfoundland in the North Atlantic. The torpedo knocked out the *Dorchester*'s electrical system, leaving the ship dark. Panic set in among the men on board, many of them trapped below decks. The chaplains sought to calm the men and organize an orderly evacuation of the ship and helped guide wounded men to safety. As life jackets were passed out to the men, the supply ran out before each man had one. The chaplains removed their own life jackets and gave them to others. They helped as many men as they could into lifeboats, and then linked arms and, saying prayers and singing hymns, went down with the ship.

*"As I swam away from the ship, I looked back. The flares had lighted everything. The bow came up high and she slid under. The last thing I saw, the Four Chaplains were up there praying for the safety of the men. They had done everything they could. I did not see them again. They themselves did not have a chance without their life jackets."* —Grady Clark, survivor

HAPPY NEW YEAR LEGIONNAIRES I hope you all had a safe and enjoyable holiday season giving yourselves a chance to rejuvenate your battery and get ready to face a brand new 2026. Our general meeting this month will include our annual Post Everlasting Ceremony and approval of our 2026 proposed budget. Thanks to our renters, we are in good shape and can afford some expanse of our outreach. In that budget is a proposal to change our current "Scholarship Fund" to a "Youth Programs Fund" where annual budget payments for all youth programs will be deposited and payments will be made out of that fund vs the general fund. This will allow us to better plan for and accommodate fluctuations in our programs such as the number of Boys State citizens we sponsor.



In that regard, as your Commander, I want this new year to have a focus on increasing participation in our Legion youth programs. Though we should be addressing these year-round, this time of year is an opportune time to target potential participants. Let's make a concerted effort to disseminate information and educate potential participants of the following youth programs available.

**1) American Legion Baseball** - Even though we do not have a team at our post, there are teams at Hillsboro Post 6 and Tigard Post 158. Last year one of Tigard's teams went to the national finals, falling to the Championship Team. For questions about American Legion Baseball, contact Mike Sowles at 503-769-4599.

**2) Jim Willis Law Enforcement Career Camp** - The camp is a week-long residential program where youth experience all aspects of Law Enforcement held at Camp Rilea. It is open to students aged 15 to 17 with recommendations from a teacher or other adult and an American Legion Post sponsor. A \$50 fee is required by the student, but the rest is covered by the sponsoring Post. This camp provides a well-rounded exposure to the many opportunities in the field of Law Enforcement. **3) Scouting America (formerly Boy Scouts)** - Our Post sponsors Troop 2060 who meet in the basement of our Post. They assist us in several of our functions such as the Flag Retirement Ceremony, placing 9/11 flags, Memorial Day grave flags, parades and the Elks Veterans Dinner. For questions, contact Mike Standing at 971-732-4619.

**4) American Legion Oratorical Scholarship Competition** - Top three scholarships at National range from \$20,000 to \$25,000. An admirable goal, but scholarship opportunities are available at Post, District, Department and National levels for all four years of high school. Top three at the Department are \$3,000-\$5,000; a significant sum can be earned over multiple years. What it takes is a willingness to speak 8-10 minutes on an aspect of the Constitution of their choosing and then a 3-5 minute speech on one of four pre-selected topics chosen each year. We are holding the 2026 District Competition on Saturday January 31st at noon in our Post. Come and see what this program is all about. I am the primary contact at 503-333-2340. I could use another judge or two if you are interested.

**5) Boys State/Girls State** - This program is a week-long mock government exercise held on a college/university campus. Local and state positions are filled by election or appointment amongst "citizens" from all over the state. A school representative generally forwards potential candidates, but many schools do not place emphasis on it. Posts, auxiliaries or other sponsors cover the cost of attendance. It equates to college credit, an excellent resume entry, and 10 points toward an academy appointment. The Legion runs Boys State and the Auxiliary does Girls State. Attendance can only be at the end of their junior year of High School; a one-time shot. The Programs will run concurrently at Oregon State University from June 21 (20th for Girls State) thru June 27. All of these programs are bundled under the Americanism Pillar with Mike Speer being the Americanism Chair and the Department Second Vice Commander. His phone number is 503-703-2757.

### LEGISLATIVE HAPPENINGS:

Public Law No. 119-42

An Act: To increase, effective as of December 1, 2025, the rates of compensation for veterans with service-connected disabilities and the rates of dependency and indemnity compensation for the survivors of certain disabled veterans, and for other purposes.

Nov. 25, 2025:

[S. 2392]

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled*  
This Act may be cited as the "Veterans' Compensation Cost-of-Living Adjustment Act of 2025".

This bill requires the Department of Veterans Affairs (VA) to increase the amounts payable for wartime disability compensation, additional compensation for dependents, the clothing allowance for certain disabled veterans, and dependency and indemnity compensation for surviving spouses and children. Specifically, the VA must increase the amounts by the same percentage as the cost-of-living increase in benefits for Social Security recipients that is effective on December 1, 2025.

## This Month in Military History:

On January 11, 1917, a fire started in Building 30 of the Canadian Car and Foundry Company at Kingsland in New Jersey. In four hours, probably 500,000 pieces of 3-inch (76 mm) explosive shells were discharged. The entire plant was destroyed. From office buildings and tall apartments, people in New York City watched with amazement.

Although the U.S. was neutral to the War in Europe at that time, the country was selling war supplies to the Allied powers due to the British blockade of Germany -- meaning that the Allies were the only potential customers. Munitions, including shells, shell cases, shrapnel, and powder were shipped to Kingsland from over 100 different factories. At the foundry they were assembled for shipment to Russia. Producing three million shells per month, the factory was a worthy objective for German saboteurs.

Building 30 was used exclusively for cleaning out shells; it contained 48 workbenches. On the bench in front of each employee was a pan of gasoline and a small rotating machine operated by a belt. The cleaning process included several steps: The shells were dusted with a brush; a cloth, moistened in the pan of gasoline, was wrapped around a foot-long piece of wood; the shell was placed in the rotating machine and the wood was inserted into the shell as it turned; a dry cloth was wrapped around the stick and the shell was dried in a similar manner.

Rumor had it that a group of saboteurs operated under the direction of Frederick Hinsch. He recruited a German national, Curt Thummel, who changed his name to Charles Thorne. Hinsch instructed Thorne to obtain employment at the factory. Thorne was hired as assistant employment manager. In this position he facilitated the hiring of several operatives sent by Hinsch to infiltrate the factory. One of those employees supposedly was Theodore Wozniak. After the Kingsland plant was completely destroyed, police and federal investigators uncovered the source of the fire. It started at Wozniak's workbench in Building 30. Other workmen alleged that the fire began in front of Wozniak's wooden roller. One of the company directors, Mr. Cahan, remarked about Wozniak's nervous behavior and contradictions during an interview about the incident. Wozniak, who admitted that he had served time as a draftee in the Austrian Army, was told by Mr. Cahan that he would be needed in New York as part of the investigation into the fire. Wozniak, who lived at the Russian Immigrant House on Third Street in New York City, eluded the detectives who were watching him and disappeared.

Kingsland resident Theresa Louise "Tessie" McNamara, who operated the company switchboard, was credited with saving 1,400 lives; despite the fire McNamara stayed at the switchboard. She plugged in each of the buildings and shouted the warning, "Get out or go up!"<sup>[3]</sup> No one was killed in the fire as a result of her announcements. Fleeing workers were able to cross the frozen Hackensack River or run up Valley Brook Avenue to safety. The National Special Aid Society later presented McNamara with a check to honor her for her bravery.

"Whatever happened, the building was in flames in an instant. Ten minutes passed before the first and mightiest explosion. In those ten minutes panic broke loose in the plant. It is believed that there were 1,400 men working in the factory. "They started to get out. The entrance to the building was by a narrow gate, guarded by 12-foot walls. In a moment this was jammed by workers, mostly Italians and negroes, who fought desperately to get away. Guards were forced at last to drive back the mob with pistols and rifles." "They broke and scattered. Many of them ran to the rear of the plant, which is separated from the swampy meadow by a high barbed-wire fence. They went through this like a drove of cattle. Frantic with terror, they paid no attention to the wire, which cut some of them cruelly, but went ploughing, the whole terror-struck crowd, through the mud and thin ice of the marsh."

"Then came the first great roar. It is said that a building in which the loaded shells were stored was the first to go." "The terrific blast spread the panic, which had hitherto been confined to the factory yard, to Kingsland and the adjoining village of Lyndhurst. After the first detonation came the steady roll of bursting shrapnel and high explosive shells. In a minute the little Jersey towns were transformed into villages upon the European battle front. Shells that had been intended for the armies of the Czar burst in terrific salvos over the roofs of the houses, shattered chimneys, riddled the car repair barns of the Lackawanna Railway, and set two dwellings on fire."


